As individuals we all have standards. We know what we will accept and what we will not accept when we go to restaurants, check into a hotel room, buy a new car or any of the million other decisions we make in our lives. From the minute we wake until that twilight vague moment before we drop off to sleep again we grade every choice we make and choose only those which are acceptable to our preset standards. The Department is setting up an account to help the Department of California. This money will go to members of the Marine Corps League and active duty Marines stationed in that state. National is looking for a convention location in our area, New York, New Jersey and Pennsylvania. If you know of a hotel or group of hotels, let the Commandant know. He will forward to Jim Ransom, the National Convention Chairman (and NY PDC).

The Suffolk County Detachment #247 was chartered on April 12, 1945, with the first Commandant being Leland Whittaker. We are the first detachment to be present in Suffolk County. Meetings were held in a small house in



Bay Shore until 1974 when the new building property was given to the detachment by the town (picture of the old building and new build-

ing). In May of 1956, a town representative assisted the detachment in obtaining the M1 57mm artillery anti-tank gun that graces out front



lawn. The Eagle was commissioned in October 1984 and has had its head replaced 5 times as vandals have



knocked it's head off whether in protest or just teenage vagrants (pictures of the eagle and the commissioning ceremony above). We also had one of our German MG-08 Machine Guns stolen from the roof of our detachment in

February 2023 - that weapon was donated to us in 1940.

- It was part of the original building decor.

In 2007, shortly after the opening of the Marine Corps League Muse-



um, the detachment purchased a brick and has continued to donate and support the history of the Marine Corps. In 2009, we began celebrating our Marine Corps



Birthday with a yearly Ball as is our tradition. In 2019 we started our Scholarship Program to provide scholarships to local school districts with students that have a Military history or plan to join the armed services. We have been the central location for Suffolk County Toys for Tots for 5 years now. In 2024 we started our Pro Bono clinic to

assist Veterans of all branches with legal services and many other services that are available to Veterans.

While we have had many significant members at our detachment, we have a Marine who was awarded 3 purple hears - Jim McCann - who also served as the Commandant from 2010 - 2011, he earned two in 1966 and 1 in 1967. We have had many local representatives as members and we currently have a Suffolk County Legislator as a full member, Chad Lennon.

The current Commandant, Jaclyn Imperati, has served as such since 2024, if the first female Commandant of their Detachment.

IMPORTANT INFORMATION

I've been Hacked!

Something none of us want yet it happens. You emails are somehow hacked and they have access to your contacts. They then send emails to all your contacts asking for funds, usually in the form of gift cards. Use common sense when you receive emails asking for gift cards from friends who may use your name but not your email address. That should be an eye opener right there. When this happens call or text the person you think may have sent this email to confirm. Never take an email at face value, especially when they are asking for money. For your protection, change your password.

To protect ourselves and our community, the department urges you to follow these guidelines:

1. **Do Not Share Personal Information:** Under no circumstances should you share personal or sensitive data in response to atypical email requests.

2. Verify Unusual Requests: If you receive an email that appears to be from PDC Wortmann or any other individual requesting unusual actions, such as financial transactions or the sharing of privileged information, please verify the request directly through established communication channels.

3. **Report Suspicious Activity:** If you receive a suspicious email, promptly report it to the FTC. To report it and learn more please visit <u>Phishing | Federal Trade Commission</u>. Your vigilance is crucial in mitigating potential threats.

4. Educate Yourself: Familiarize yourself with common email scams and phishing techniques to better protect your information and our organization. (see the FTC link in item #3).

Essex County Leathernecks Plan birthday ball

Marine Corps to celebrate 250th anniversary

TICONDEROGA I This November, the Essex County Leathernecks are planning to host an event that doesn't happen very often, and they will make sure it is one for the ages. On Nov10, 2025, the United States Marine Corps will celebrate its 250th anniversary, an occasion surely marked by fanfare. In the North Country, the Leathernecks will throw a grand 250th Marine Corps Birthday Ball to commemorate two and-a-half centuries of the branch of the American military that acts as the premier crisis response force.

"The Birthday Ball will be open to any and all residents, military or not, all are welcome to attend," said Walter Peterson, Commandant of the League. We are hoping to see people from all branches of the military, people who have been out of the area awhile, as wells people who may be passing through to celebrate with us. This celebration will be on a larger scale than what most small detachments are able to do."

Detachment 791, Essex County Leathernecks (the term 'leatherneck' was started during WWI when the Marines had leather sewn into uniforms to protect their necks from slashing sword blades in battle) of the Marine Corps League is classified as a veteran/military service organization and was formed for the purposes of promoting the interests of the U.S. Marine Corps. Providing camaraderie and assistance to Marines, as well as to their widows and orphans, the League (based in Crown Point and Ticonderoga with between 40 and 50 members) aims to preserve the traditions of the U.S. Marine Corps.

Put into action locally, the Leathernecks participate in parades, military funerals, create Easter baskets for the elderly, assist in community functions, and support the Toys for Tots program. They also hold a local essay contest for all Essex County High school seniors, awarding four students with \$500. In the fall of 2022, the Leathernecks unveiled an impressive even-foot-high polished black granite monument that specifically honors Marines from the Adiron-dacks in Crown Point's Veterans Park.

The Leathernecks are active, and they stand for something. And for the Birthday Ball, they intend to pull out all the stops.

For those who like to dress up and look spiffy, this is the event for you. Ladies will don evening dresses and ball gowns.

"This will be a formal event," Peterson said. "A lot of us will be in uniforms or tuxedos or black ties."

The Birthday Ball is slated for Saturday, Nov. 15, the venue yet to be determined. There are local contenders for the location, and the location will be locked in at their next business meeting on Mar. 6. In years prior, the Leathernecks

held their celebrations at the Ticonderoga EMA when it was a banquet hall, with turnouts averaging 100 people, 185 being their biggest. Peterson is anticipating the November event may also see record numbers. There will be a sit-down dinner, drinks, music and dancing, and the Leathernecks desire a venue that will have hotel accommodations so that guests will have no worries and be able to fully enjoy the ball.

According to Peterson, the Birthday Ball will put a major emphasis and focus on the Marine Corps' traditions and rich history.



"A big part of boot camp or Officer Candidate School (OCS) is that you are taught the history and traditions of the Marine Corps," he explained. "There are certain things that will take place at the ball that have been taking place since the 1920s. We have an official cake-cutting ceremony with pieces of cake going to the oldest Marine present and then the youngest Marine present. There is a message that is read every year from General Lejeune from 1923. His message is read at every Marine Corps birthday celebration, we also read the current Commandants and Sergeant of the Marine Corps."

Peterson is a third-generation Marine, serving from July of 1992 to August of 2015. He praises his time in the corps as the most influential and character-building experience of his life.

"The entire experience breeds camaraderie and esprit de corps," he remarked. "You make friends that will last a lifetime, and it gives you discipline to get any job done. There is a saying that we always revert back to, 'Improvise, adapt, and overcome.' You can relate that to pretty much any job in the world."

The Essex County Leathernecks will soon be distributing a sponsorship form for any local businesses who would like to have their name mentioned or a table in their honor at the ball. At the official ceremony in 1913, to open the Panama Canal, a tug loaded with US Army officials prepared to be the first to transit the locks of the canal. As soon as the vessel started, a canoe appeared alongside with two marines on board that padded furiously to pass the tug and take the unofficial honors.





And we fired the first shots of WW1

The United States would not enter the war on the side of the Allies for nearly three more years, and when it did, the first shot an American serviceman fired at an enemy in that colossal conflict was not in the trenches in France or on the battlefields of the eastern front, but in the harbor of a Pacific

island. The German mer-

chant raider Cormoran put into Guam, on December 14, 1914.



Guam was American territory, and the United States was still neutral. Nearly out of coal, the Cormoran and her crew were interned by American naval authorities and remained in Apra for the next two years.

On April 7, 1917, the United States declared war on Germany and boarding parties of sailors and Marines led by Lieutenant W.A. Hall, USN, stationed on Guam, went to seize the ship. When a boat from the Cormoran was seen headed for shore, Hall ordered Corporal Michael Chockie, USMC, to fire a shot across the boat's bow – the first American shot fired of World War I. At first, the Germans ignored the warning, but after Chockie and other men fired several more shots into the water near the boat, its crew hove to. The German captain then blew up his ship killing several German sailors.

As described in the archives of the Naval History and Heritage Command, "This brief encounter at Guam resulted in the first violence of the war, the first Germans killed in action with the United States, the first German prisoners of war captured by the United States forces, and the first shots fired between the U.S. and Germany.
